Collection

Data is collected and indexed from social media streams, linked content and websites through APIs and direct web navigation. X1 Social Discovery aggregates data from these multiple sources in real time, in a highly scalable and case-centric manner.

Authentication

MD5 hash values of individual social media items are calculated upon capture and maintained through export. Automated logging and reports are generated. Key metadata unique to social media streams are captured through deep integration with APIs provided by the sites.

Search

Perform broad, unified searches across multiple accounts, social media streams and websites from a single interface. Linked content is automatically indexed and searched and the results are aggregated for sorting, tagging and export consistent with standard eDiscovery workflow.

Production

Maintain social media data in a searchable native format from collection through production, uniquely providing a complete platform to address social media in the same manner as e-mail and e-documents.
